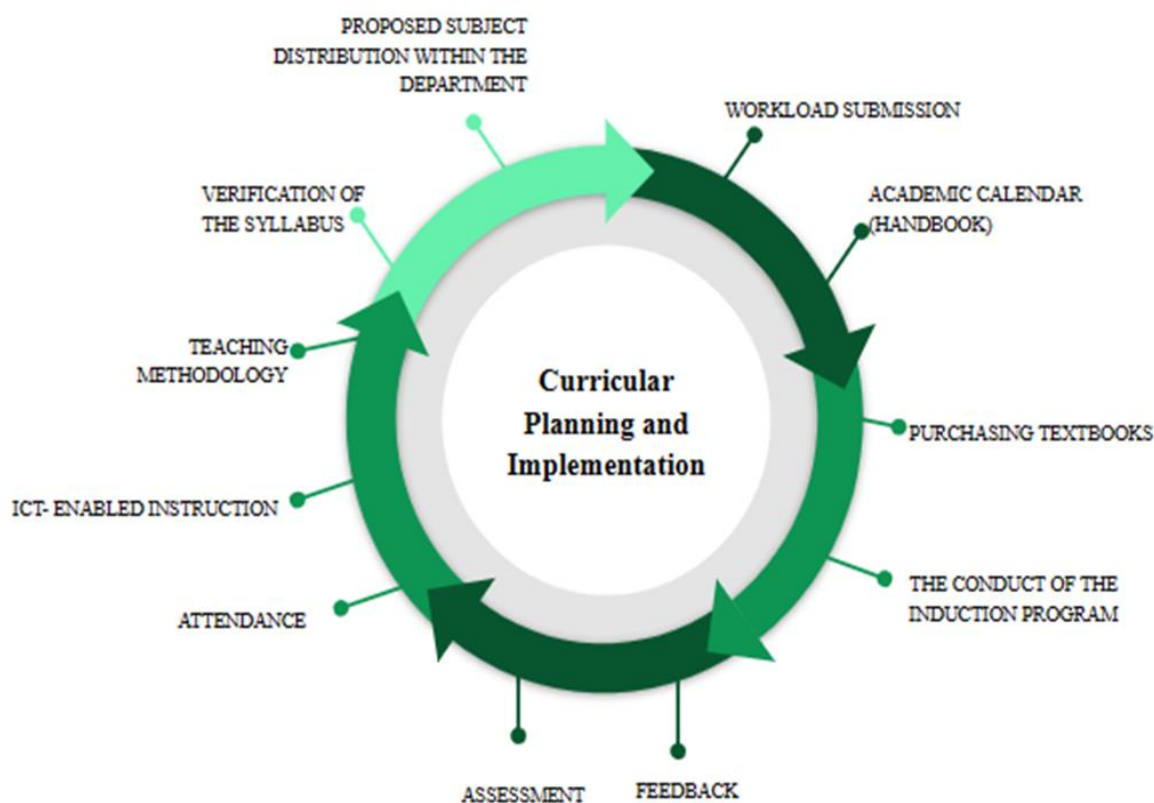


CRITERION 1 - CURRICULAR ASPECTS

1.1 Curricular Planning and Implementation

1.1.1 The institution ensures effective curriculum planning and delivery through a well-planned and documented process including academic calendar and conduct of continuous internal assessment.



Our institution, affiliated to Bharathiar University, Coimbatore, meticulously plans syllabi for upcoming semesters in advance, aligning with the academic scheme set forth by the university in preceding semesters. The university periodically revises the syllabi to reflect current scenarios and requirements.

Paper Allotment: The department assigns subjects for the next semester based on faculty members' experience and preparedness to handle specific papers, as outlined in the syllabus available on the university website. To ensure comprehensive coverage of the curriculum, each faculty member is assigned a distinct subject to teach.

Workload Submission: By the end of the previous semester, it is expected that all faculty members of the departments submit their workload and schedule for the upcoming semester to the Head of the institution. This practice helps ascertain faculty availability, considering factors such as potential transfers or retirements, and confirms the timetable.

Academic Calendar (Handbook): Subsequently, the institution creates the academic calendar, detailing the number of working days and holidays. This calendar also includes essential guidelines such as institution protocols, do's and don'ts, and procedures for obtaining transfer certificates and legitimate certificates.

Implementation in the Academic year/semester

Verification of the Syllabus: On the day of reopening, a general meeting is organized to discuss and finalize updates to the syllabus. Additionally, in the event of staff shortages or new appointments, a plan is devised to distribute the workload among the existing faculty members within the department.

Induction Program: An induction program is conducted for all the freshers to familiarize them with the college. This program serves as an introductory session for students to understand the significance of higher education and government welfare schemes.

Teaching Methodology: Each teacher tailors their teaching methodology based on the complexity of the material and the students' competency levels. The POs and COs guides the delivery of classes. Various techniques, including walk-and-talk sessions, team teaching, peer-group teaching, group discussions, seminars, assignments and quizzes, are employed to create conducive learning environment in the classrooms.

ICT-Enabled Instruction: Each mentor maintains consistent contact with students through WhatsApp groups, facilitating easy communication and support. Assignments are distributed via Google Classroom, and supplementary materials such as audio files, YouTube links, and content are shared within the WhatsApp groups.

Attendance: A minimum attendance of seventy-five percent is required for students to be eligible to appear for the end-semester examinations. Regular updates on students' attendance in class are communicated to parents to ensure transparency and accountability.

Feedback: Students' opinions on the curriculum's elements are gathered at the exit level. However, every semester, each faculty member receives a frank evaluation about how well they are teaching, which aids in the improvement of their methodology.
